# BAR K BAR ARENA RENTAL AGREEMENT

## RENTAL AGREEMENT

Rental prices are for normal configuration of arena fence and grounds prepared in normal good show condition. Any other special requests for different arena equipment, configuration or grounds will be subject to extra charges.

A tractor will be provided for you to work the grounds twice per day for your event. Additional demand for the tractor will be charged according to the number of entries each day. If a tractor driver is required a \$50 per hour charge will be assessed.

The arena ground will be watered and worked prior to your arrival. If more water is required an additional fee will be assessed dependant on if the request was pre-planned or not.

Keys will be given to the Renter for entrance into the Foyer, the Commons and the electrical panel as needed. Lost keys will have a replacement charge of \$25.00. Replacement costs will be charged to the Renter for any damaged or stolen furniture or art work.

Celebration Centre LLC prohibits the use of smoking inside the Arena building. No sale of alcohol is allowed on the premises by anyone other than the Celebration Centre LLC licensed concessionaire holding a current Kansas Malt Beverage License. All beverages are to be consumed within the Bar K Bar Arena building. No outside food vendors are allowed to sell on premise without prior consent. \_\_\_\_\_(initial)

Only the actual number of bales, stalls and electrical hook-ups used will be charged. Work lights will be available during setup and practice. Show lights will be used for show time only. **Show lights kept on after show is over each day and work lights kept on after 10pm will result in an additional charge of \$25.00 per hour.** \_\_\_\_\_(initial)

Please do not stall horses in the livestock pens. Stalls are available for use and a back charge will be invoiced for any horses kept in these pens.

Set up day will allow you access to the arena after 5:00 PM. If no other events are booked earlier access may be allowed but not guaranteed.

It is the responsibility of the Renter to pick up all bottles, cans and trash inside the arena and in parking lots and placed in the trash dumpsters. The renter will be charged a cleaning fee of \$200.00 if the Celebration Centre LLC employees have to clean the area. Any damages to the buildings or grounds are the responsibility of the Renting group or Individual. \_\_\_\_\_(initial)

All dogs are required to be on a leash in the Arena and on the grounds. No dogs except Seeing Eye Dogs are allowed in the Commons per 2005 Kansas Food Code: 6-501.115 Prohibiting Animals.

**Deposit is due upon signing of the contract. Deposit will be refunded if all policies are adheared to within ten days of completion of the event.**

**All rent / stall / RV / shavings etc. due to the Bar K Bar Arena are due and payable to he Celebration Centre LLC on the last day of the event for these contract dates. NO EXCEPTIONS !**

CANCELLATION POLICY: Events cancelled more than 30 days before the event will not be charged a fee. Events cancelled less than 30 days before the first day of the event will be charged ONE days Arena Rent if not rescheduled.

It is hereby agreed that person(s) or oranizations(s) renting these facilities assume(s) the responsibility of reimbursing the Celebration Centre LLC for the rental fees as above. It is further agreed that said person(s) or organization(s) will provide adequate supervision of the Arena and grounds and will be liable for payment of damages to the property that may occur.

I am hereby noified that Celebration Centre LLC is not liable for any injury or death of any participant or spectator with the premises at any time. **The Renter also assumes responsibility for any and all bodily injury and/or property damages that are caused by your organization and/or participants to an spectator while at your event.** I have read and understand my obiligations for my rental of the facilities of Bar K Bar Arena.
